Legislative Update: *Another “Special” Interim*

While Texas only holds a regular legislative session every other year, recent history makes it feel like the Legislature is always “in session.” Governor Abbott has once again called multiple special sessions.

- The first special session adjourned with all bills left incomplete, after Democratic members left the state to break quorum and prevent passage of new congressional maps.
- The second special session was called immediately afterward, with Governor Abbott expanding the call both before and after the session began.

TLMA continues to monitor developments and will keep members updated as the situation evolves.

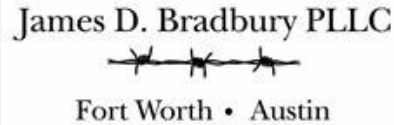
