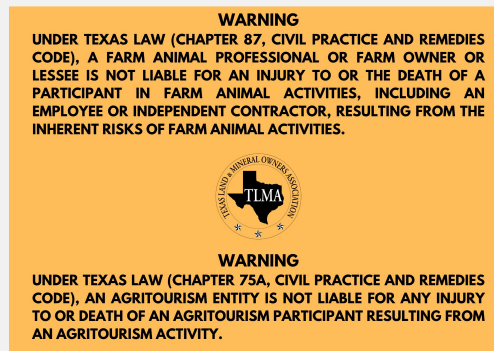
TLMA WELCOMES NEW CHAIRMAN
