

# July 2025 Monthly Update



## **Special Session #1**

The Texas Legislature convened for its first special session on July 21 with a far broader agenda than originally announced in mid-June. In response to the devastating Fourth of July floods, Governor Abbott added numerous flood-related items to the call along with redistricting, pro-life legislation, and restrictions on taxpayer-funded lobbying.

So far, the Legislature has focused primarily on flood relief, redistricting, and THC-related measures, though no bills have yet passed both chambers. Each special session lasts up to 30 days, and the Governor may call unlimited additional sessions if needed.
