You can view the ballot language at this [link](#). Each proposition includes a corresponding bill number, which you can look up on [Texas Legislature Online](#) for full statutory language.

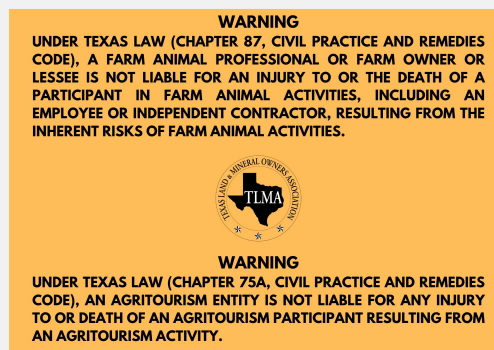
The next election will be the primary election to be held in March 2026.

RRC RECEIVES CLASS VI PRIMACY

After several years of preparation, the Railroad Commission of Texas (RRC) has officially [received primary enforcement authority](#) ("primacy") from the EPA for Class VI (carbon dioxide injection) wells.

The RRC previously completed the necessary rulemaking as part of its application. Those regulations can be viewed at this [link](#).

The RRC has also published [FAQs](#) to help stakeholders navigate Class VI primacy and related requirements.

RRC RULE APPROVAL – HB 2663 IMPLEMENTATION

At the August 19 open meeting, the Railroad Commission proposed rule changes to implement HB 2663 by Chairman Drew Darby. The bill requires operators to affirm that electrical service equipment has been removed from a site when requesting a well-plugging extension. TLMA filed comments in support of the rule as mentioned in the October update.

The [rule was formally approved](#) at the November open meeting and will take effect December 8, 2025.
