## TLMA Comments on Railroad Commission Rulemaking

During the 89th Legislative Session, Chairman Drew Darby filed HB 2663 in response to the 2024 Panhandle wildfires. The bill requires operators seeking a well-plugging extension to affirm the removal of electrical service equipment from the site.

TLMA supported the bill and successfully advocated for an amendment requiring the Railroad Commission (RRC) to impose penalties for violations.

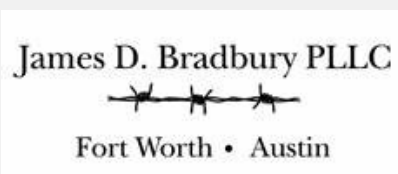
