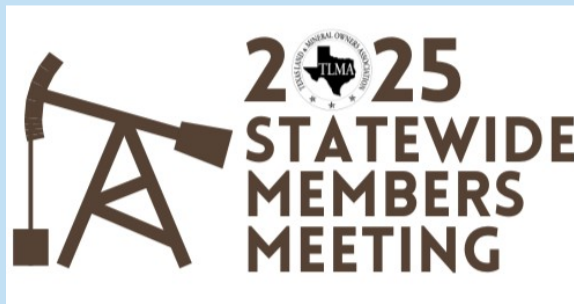

## RRC Rulemaking on HB 2663

The RRC is seeking comments on the proposed rules implementing HB 2663 by Chairman Drew Darby. HB 2663 requires operators who apply for a plugging extension of an inactive well to provide written affirmation of the removal of the electrical equipment that provided power service to the well site.

## Judicial Update

This month has been busier than usual on the judicial front.

Cactus Water Services filed a motion for rehearing in the produced water case [Cactus Water Services v. COG Operating](#). The Supreme Court denied the motion for rehearing, and the ruling in favor of the operator stands.

Oral arguments in the easement case [Boerschig v. Rio Grande Electric Coop](#) will be Wednesday, November 5, 2025. TLMA filed a brief in the case ([link](#)).

Additionally, oral arguments in [Clifton, et. Al. v. Scott W. Johnson and Florence H. Cummings](#), a case involving royalty fraction calculations, will be December 2, 2025.

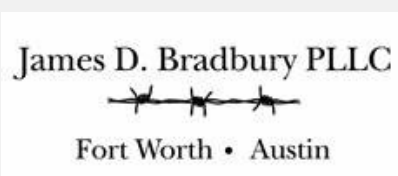
