TLMA FILES COMMENTS TO HOUSE LAND & RESOURCE MANAGEMENT COMMITTEE REQUEST FOR INFORMATION

Earlier this year, the Speaker of the House announced the interim charges for each committee. TLMA was closely following the House Energy Committee, the Ways and Means Committee, and the House Land and Resource Management Committee. We were eagerly awaiting the announcement of interim hearings when COVID hit. Since the situation has remained the same regarding social distancing, some committees requested information to be submitted on each of the charges.

TLMA filed brief comments on interim charge #2.

2. Review, in coordination with the Office of Attorney General, the efficacy of the Landowner's Bill of Rights (LBoR) in explaining to landowners the eminent domain condemnation process and their rights and responsibilities under Chapter 21 of the Property Code. Identify any omitted information which can enhance the landowner's understanding of the condemnation process and determine whether any other changes should be made to the document to make it more user friendly. Determine whether it would be beneficial for the legislature to be more prescriptive in statute 2 with the mandatory contents of the LBoR.

TLMA's comments focused primarily on the LBoR being a small part of a much larger process and adding information to a single document is not the fix to establishing fairness in the condemnation process.

Two additions that TLMA suggested are :

- The landowner's right to challenge the entities authority to condemn land. The LBoR currently only speaks to the award amount.
- Include information on what property the entity has the legal authority to condemn

2020 STATEWIDE MEETING ZOOM WEBINAR INFORMATION & INSTRUCTIONS

TLMA will use the Zoom Webinar platform to conduct our 2020 TLMA Statewide Members Meeting. (This is not the same as Zoom Meeting.) You will be able to see the presenter and their presentation at the same time, but will be in a listen only function. This means as a participant you can only listen and cannot freely communicate back to the speaker. However, Zoom Webinar enables the chat and raise your hand functions. You will be able to “chat” with each other during the presentations.

You do not have to have internet access to listen to the presentations. If you do not have access to the internet or a computer to use Zoom Webinar, you will be able to call in from your phone and listen. If you do not have internet access, we will mail a copy of the presentations and call in information to you **by request only**. If you have access to internet, PLEASE do not request the presentations. They will be available to you after the meeting. Meeting packets must be requested by **September 21. They will be mailed the following week.** To request a packet:

RRC CANDIDATES FOR THE GENERAL ELECTION

On November 3, Jim Wright and Chrysta Castañeda will face off in the General Election to become the next Railroad Commissioner. Jim Wright defeated incumbent Ryan Sitton in the primary election. Chrysta Castañeda defeated Robert “Beto” Alonzo in the Democratic runoff. You can learn more about their positions on their websites listed.

Chrysta Castañeda (chrystafortexas.com)

Chrysta Castañeda is an engineer, a lawyer, a community leader, and a mom. After receiving her degree in industrial engineering from Kansas State University, Chrysta earned her law degree from Southern Methodist University Dedman School of Law, where she graduated cum laude.

As the founding partner of her law firm in Dallas, Texas, Chrysta focuses on oil and gas litigation in the upstream sector, as well as commercial litigation and products liability disputes involving technical evidence. Her winning verdict in Pecos, Texas for an oil and gas plaintiff has been recognized by the National Law Journal and named to the Texas Lawyer's Verdicts Hall of Fame.

In addition to her successful career, Chrysta has held leadership positions in a variety of non-profit agencies focused on improving women's lives. She is a board member of the Texas Women's Foundation and was previously the board chair of Ignite Texas, a non-partisan organization focused on building political ambition in young women.

The Texas Railroad Commission is the state agency that oversees all oil and gas drilling—one of the largest drivers of the Texas economy. Oil and gas production is not going away any time soon and it is a vital part of the Texas economy, but the Commission is not enforcing the law. Jim and his family live on a ranch outside of Orange Grove, Texas. An avid Christian, Jim is a Lutheran and when possible attends many of the state's Cowboy Churches, where his son Luke is a well-known speaker and preacher. Jim and his wife, Sherry, have five children.

As a high school student, Jim was in the national finals of the National High School Rodeo Association (NHSRA) before graduating from Calallen High School in Corpus Christi. He rode bulls for over 20 years and was a member of the Professional Rodeo Cowboy Association (PRCA). He has also been involved in numerous civic activities including as a board member of C.A.S.A. (Court Appointed Special Advocate) of the Coastal Bend and the Robstown Area Development Commission.

A strong pro-business Texan, Jim is running because he believes that we need to restore integrity and trust in the Texas Railroad Commission. Even though he has never been involved in politics, Jim knows how to bring everyone to the table. Jim intends to include a multitude of stakeholders, from industry to consumers and the public sector in developing policies on the Commission. He believes that we need to build trust from the public and the industry the Railroad Commission serves and hopes to develop strong ethics rules for agency employees, get citizen and industry input for needed changes in the regulation of the energy sector and promote transparency on the Commission.

2020 STATEWIDE MEMBERS MEETING VOTING INFORMATION

Section 4.13 of the TLMA bylaws permit voting to be conducted by mail. Because TLMA is not meeting in person this year, we will vote by mail. Each member of the association will receive a ballot. If you and your spouse are under a single membership, you will only receive **one** ballot.

Ballots will be mailed at the beginning of September. You will have until **September 28** to postmark your ballots back to the TLMA office. We will announce the results during the business meeting of the meeting. If you do not receive your ballot, please call or email the TLMA office.

You will be voting on the 2020 TLMA Board of Directors, District Representatives and the 2020 by-law amendments.

Recently, TLMA has received requests from entities that provide services to our members to become members of TLMA. The founding members of TLMA wanted to ensure that the TLMA bylaws were structured to protect the land and mineral owners.

The proposed changes to the bylaws allows entities that provide services to our members the ability to join TLMA at an elevated membership due level. The Board of Directors will have discernment over approving the entity to join. *If approved, these changes will take effect January 1, 2021.*
