KINDER MORGAN'S PERMIAN HIGHWAY PIPELINE: NOT JUST ANOTHER PIPELINE PROJECT

Introduction

In the summer of 2018, Kinder Morgan Texas Pipeline ("KMTP") and EagleClaw Midstream Ventures made a preliminary announcement of a new pipeline dubbed the "Permian Highway" and in September of 2018 announced a final investment decision to proceed with a pipeline project. The 42" diameter high pressure pipeline will run approximately 430 miles, from the Waha Hub in West, Texas to its terminus in Colorado County near Columbus, Texas transporting up the 2.1 billion cubic feet of natural gas per day. At the time the new pipeline was announced, it was reported that EagleClaw Midstream Ventures, XTO Energy, Inc. (a subsidiary of Exxon Mobil Corporation), and others had committed to transport natural gas through the new pipeline.

The fact that a major international pipeline company announced a new pipeline was not remarkable in and of itself. There are roughly a dozen or so other large oil or gas pipelines connecting the Permian Basin with the Gulf Coast either planned or under construction and the addition of another such project would not normally raise many eyebrows. What made the Permian Highway Project ("PHP") very unique, though, is the route that was chosen. Most pipelines that stretch from the Permian Basin in West Texas to the Gulf Coast run south of San Antonio, predominantly through the Eagle Ford Shale areas, or near Abilene then north or south of Waco and on to the Gulf Coast. When the initial routing of the PHP pipeline was announced, however, the route through Junction, Harper, Fredericksburg, Woodcreek, Wimberley, Blanco, Kyle, Lockhart, Hallettsville and on to the Gulf Coast made this project very different. Just over 1,050 individual landowner parcels would be affected by the project.

From the outset, the project was met with significant resistance, not just from those landowners who believed they would be directly affected, but also from local communities, activists, and local governments. When landowners and other interested parties learned that the Texas Railroad Commission and other governmental agencies had very little – if any – oversight on the routing of large high-pressure pipelines like the PHP a firestorm of opposition was fanned.

Opposition

Landowners and others opposed to the project informally joined together and also formally formed organizations to oppose the project. The formal opposition began with the passage of several resolutions by local governmental entities, like Hays County, Gillespie County, the City of Kyle, the City of San Marcos, the City of Fredericksburg, some groundwater conservation districts, a school district or two, and even the Fredericksburg Convention and Visitor Bureau. The formal opposition came to a head with the filing of a lawsuit in Travis County against KMTP, PHP, the Texas Railroad Commission, and the individual Texas Railroad Commissioners in their official capacity. See Cause No. D-1-GN-19-002161; Sansom, et al. v. Texas Railroad Commission, et al.; in the 345th Judicial District Court for Travis County, Texas. The suit took issue with the Railroad Commission's failure to promulgate rules regarding the routing of pipelines, but was ultimately dismissed following a two-day evidentiary hearing.

The City of Kyle, one of the cities that would have the line run through it, also passed a series of ordinances that would require minimum burial depths and other safety requirements. KMPT and the Permian Highway then sued the City in federal court in Austin seeking to invalidate the ordinances. See Civil Action NO. 1:19-CV-00724; Permian Highway Pipeline, LLC and Kinder Morgan Texas Pipeline, LLC v. City of Kyle, Texas, in the United States District Court for the Western District of Texas, Austin Division. Before the suit in federal court made it very far, it was reported that KMTP/PHP and the City of Kyle have reached a tentative settlement of the issues in the suit.

More lawsuits by landowners have been threatened.

Status of the Project

PHP began the formal condemnation process by making initial offers to some affected landowners as early as November of 2018, although most initial offers were not made until early 2019. Initial offers were followed by final offers in the spring of 2019 and by April 2019 PHP had began filing formal petitions in condemnation. Many cases had settled during the negotiation process, but a disproportionate number of cases had not been settled during early negotiations as compared to other large cross-state pipeline projects. *Continued on page 5*

KINDER MORGAN'S PERMIAN HIGHWAY PIPELINE: NOT JUST ANOTHER PIPELINE PROJECT CONTINUED

By the summer of 2019, PHP had begun proceeding with special commissioners' hearings, which is the administrative first step in the condemnation process whereby three special commissioners appointed by the judge assigned to the condemnation case hear evidence from both parties and render an award. Either party may then object to the award and if an objection is filed the case goes back to court and proceeds on with a trial anew, called a trial de novo.

In most traditional pipeline easement condemnation cases the dispute is primarily whether there are remainder damages, or a diminution in value to the surrounding property, caused by the taking of a pipeline easement and if so, how much the property value has been diminished. The special commissioners appointed in the PHP cases that have been hearing evidence as part of this project generally seem to agree that the pipeline easement takings as part of this project do cause some diminution in value to the remainder property. There has been significant interest from local communities and other landowners in the special commissioners' hearings, with many drawing an audience of attendees with no stake in the outcome of the hearing which is unusual.

Many hearings have occurred and objections to the award of the special commissioners have been filed, converting the cases to regular civil cases for trial anew. There is no way to definitively predict how the cases will ultimately be resolved, although most civil cases, including condemnation matters, are resolved prior to trial. Right-of-way acquisition remains ongoing as of today.

HOUSE OF REPRESENTATIVES ISSUE INTERIM CHARGES FOR 86TH LEGISLATURE

House Speaker Dennis Bonnen released the interim charges for each committee to prepare for the 2021 Legislative Session. These items can include items that were not completed during the previous legislative session or new issues. The Committees with issues of importance to TLMA members are included below. For a full list, please see the House of Representatives website. There have not been any hearings scheduled to date. We will post those dates as soon as they are available.

House Committee on Energy Resources

- 1. Monitor the agencies and programs under the Committee's jurisdiction and oversee the implementation of relevant legislation passed by the 86th Legislature. Conduct active oversight of all associated rulemaking and other governmental actions taken to ensure intended legislative outcome of all legislation.
- Study the adequacy of the workforce currently available to the industries responsible for energy production and how state policies may facilitate investment in public infrastructure and workforce development. Examine the labor needs within oil and gas exploration, production, and transportation to identify workforce gaps and the resulting effects on industry expansion, economic growth, and increasing population.
- 3. Evaluate the status of water recycling and reuse efforts in the oil and gas industry in Texas and elsewhere. Evaluate options for tax credits, deductions, or discounts to encourage recycling, treatment, or reuse of produced water from oil and gas production activities. Make recommendations on statutory or regulatory changes needed to promote recycling and reuse strategies for produced water. (Joint charge with the House Committee on Ways & Means)
- 4. Study the growth challenges of energy producing regions in Texas and the impact energy explorations and production have on state and county roads, infrastructure, health care, education, and public safety. Make recommendations for statutory and regulatory changes to improve public safety, alleviate volume of truck traffic, mitigate strains on local infrastructure, and better manage adverse impacts on communities in energy sector areas of the state.
- 5. Monitor the State Auditor's review of agencies and programs under the Committee's jurisdiction. The Chair shall seek input and periodic briefings on completed audits for the 2019 and 2020 fiscal years and bring forth pertinent issues for full committee consideration.

House Committee on Environmental Regulation

1. Monitor the agencies and programs under the Committee's jurisdiction and oversee the implementation of relevant legislation passed by the 86th Legislature. Conduct active oversight of all associated rulemaking and other governmental actions taken to ensure intended legislative outcome of all legislation, including the following: HB 2771, which facilitates the transfer of "produced water" regulatory authority from the Texas Railroad Commission to the TCEQ in order to prepare for the delegation of the National Pollutant Discharge Elimination System by the United States Environmental Protection Agency to the TCEQ. Examine which state agency has jurisdiction over different types of contamination. Determine any exemptions or regulatory holes that need to be adjusted or addressed.

House Committee on Land & Resource Management

- Review, in coordination with the Office of the Attorney General, the efficacy of the Landowner's Bill of Rights (LBoR) in explaining to landowners the eminent domain condemnation process and their rights and responsibilities under Chapter 21 of the Property Code. Identify any omitted information which can enhance the landowner's understanding of the condemnation process and determine whether any other changes should be made to the document to make it more user friendly. Determine whether it would be beneficial for the legislature to be more prescriptive in statute with the mandatory contents of the LBoR.
- 2. Study property owner's rights in eminent domain to examine and make recommendations on what should and should not constitute an actual progress to ensure the right of property owners to repurchase property seized through eminent domain by a condemning entity

TEXAS SENATE ISSUES INTERIM CHARGES FOR 86TH LEGISLATURE						

Joint Charges for Natural Resources and Economic Development Committee and Water and Rural Affairs Committee

- Eminent Domain: Examine current law regarding the balance of private property rights and continued improvement in oil and gas infrastructure. Make recommendations to ensure stability between private property owner protections and emergent oil and gas infrastructure.
- Future Water Supply: Examine current laws, processes, and water storage options and availability. Make recommendations promoting the state's water supply, storage, availability, valuation, movement, and development of new sources.
- River Authority Infrastructure: Examine the roles and responsibilities of river authorities in maintaining their managed assets including, but not limited to, dams. Evaluate the impact on the economy, water supply, and flood control due to deferred maintenance. Make recommendations to promote infrastructure stability and maintain the usability of these bodies of water.
- Groundwater Regulatory Framework: Study the state's groundwater regulatory framework and make recommendations to improve groundwater regulation, management, and permitting.
