Two Texas House Committees Hold Hearings – Culture, Recreation and Tourism and the Select Committee on Securing Texas from Hostile Foreign Organizations

The House Committee on Culture, Recreation and Tourism held a hearing to discuss conservation easements in July.

The House Committee on Securing Texas from Hostile Foreign Organizations held a hearing to discuss the threats from various hostile countries and organizations. This hearing did not focus solely on the ownership of land, but this subject frequently came up. The primary concerns around real estate regard the enforcement of the law: 1) who is responsible for ensuring the purchaser is not a hostile foreign organization, and 2) how to reverse any financial transactions.

The House Agriculture and Livestock Committee will host a hearing on foreign owned ag land on Tuesday, August 13, 2024, at 10 am. It will be held at the Capitol but will also be available via livestream.
